


#### STRATEC AT A GLANCE



- Market leader in automation solutions for the diagnostics industry and translational research

- Acquisition of Diatron (Hungary) and Sony DADC Bioscience (Austria) in 2016







## **CHALLENGES**

#### Major challenges require action

- STRATEC's growth, strategy and business objectives obstructed by incoherent PLM and ERP software
  - Different PDM, ERP software solutions in different locations
  - No or weak support of company requirements
  - Many individually developed solutions make handling of the software difficult and inefficient
  - Not prepared for fast integration of future acquisitions
- Integration of recently acquired companies requires immediate action and issue resolution until end of 2017
  - Sony DADC system in Austria has to be left until end of 2017
  - Outdated ERP software at Diatron needs to be changed quickly
  - Outdated PDM System at Stratec, no PDM at Diatron
  - Integration of these companies in the internal engineering and manufacturing footprints.



## **DECISION**

#### Windchill PLM and SAP ERP to be implemented in the STRATEC group

- STRATEC board decided to implement Windchill PLM and SAP ERP in all companies and subsidiaries of the Stratec group to resolve the current issues and to be prepared for future growth
- PLM focus will be on CAD Data and Product Structure Management in all engineering locations
- ERP focus will be on STRATEC Consumables in Austria and Diatron in Hungary to reach a go live until January 1 in 2018
- ERP at STRATEC's headquarter and its subsidiaries in Switzerland and UK most likely will follow until January 1 in 2019




# **OBJECTIVES**

  - Clear and transparent IT architecture
  - STRATEC prepared for new business requirements and the integration of future acquisitions

  - Diatron runs on new and stable ERP software




## PLM - ERP interface: Basics for 2017

- One unique place to manage the Product Structure = Windchill
- Mechatronic Product Structure for maximum transparency across the group
- One common platform for all developments (All products, tooling, gauges, etc...)
- A unique interface to ERP where all plants defined (Budapest and Anif for 2017)

## First feedback

- Requirements have to be stated completely and in a clear way (Company interest beats individual interest, no modifications)
